Mr. Mirzabegian discussed the proposal for the dissolution of the Antelope Valley Outpatient Imaging Center (AVOIC) joint venture. The board's finance committee approved the dissolution. The current structure of the JV is a 70/30 owner ship with RIMA and AVH. The business was evaluated and returned at a negative position. The only asset in the operations are the workforce and the equipment. The JV will be dissolved and AVH will purchase the AVOIC and have full ownership. AVH will run AVOIC as an independent center along with the additional satellite locations.
