#### Statement of Income - May 2022

- Total Operating Revenue: Actual=41.1 Budget=51.8 LY=44.8 / -8.3% Variance from LY
- Total Operating Expenses: Actual=37.4 Budget=44.5 LY=40.3 / -7.3% Variance from LY
- EBIDA: Actual=8.9% / Budget=14.3% / LY=9.8% / -17.4% Variance
- Net Income: Actual=6.8% Budget=10.9% LY=5.4%
