EBIDA – 3.9M (9% for March)
Operating Income - 1.8M versus a 2.8M loss last year
Total Income for March – 575K versus -2.9M loss the previous year

Operating Revenue – 358.7M versus \$334M the previous year Expenses - 342M versus \$319M the previous year

#### Month to Month

Gross Patient Revenue – 166M versus 151M from the previous year Total Revenue – 35.8M versus 31M the previous year Total Operating Revenue – 44M versus 35M the previous year

Salaries and contracted labor were much higher than the previous year – 25.7M Operating Expenses – 40M versus 35M the previous year Net income is positive versus a negative the previous year The budget year end in June

Adjusted patient days a little low - 10.3%

Observation days – 312

LOS decreased

Deliveries – 284 compared to 351

Surgeries increased in March – 358

Inpatient volume increased

Outpatient surgeries increased - 750 compared to 518 the previous year
